As a vital health resource to the San Fernando Valley since 1958, Valley Presbyterian Hospital has been providing excellent care to the community for over 60 years. 2018 was a great example of how we have adapted to meet the needs of those we serve. Towards the end of the year, we completed our Emergency Department renovation project, which accommodates 10 more treatment beds, enabling physicians to treat more patients with greater effectiveness. At an average rate of 4-5 patients per day, per bed, that's up to 50 additional patients per day and more than 18,000 over the course of a year. We understand that our patients are not numbers – they're part of our extended family, and the reason we are here.

Our commitment to providing the community with high-quality care and services is embodied by our Board of Directors, our 1,600 employees and our Medical Staff of more than 500 physicians.

Patient Story

This past holiday season was especially difficult for a patient and her family that was staying in the Pediatric Unit at Valley Presbyterian Hospital. The patient's nurse, Jackie, overheard a family member talking to the patient's physician regarding some financial struggles the family was facing.

Jackie responded by purchasing a Christmas tree and decorating it to help this family with a joyful celebration. Harmony, Child Life Specialist, and the VPH Pediatric staff worked in tandem with Jackie to provide gifts and donations for the children in this family. Jackie's generosity brought this family to tears, and they were overcome by the joy of the season.

"Jackie is more than a nurse, we are calling her our Christmas angel," said one family members. "She gave our daughter all that she wanted this year. Her wish was for a Christmas tree. Acute Rehabilitation Services

We provide patients with acute rehabilitation needs with an interdisciplinary team that delivers holistic, patient-centered care. Led by a board-certified physical medicine and rehab physician, the team includes 24-hr on-call nurses, physical therapists, a neuropsychologist, and a broad range of specialists.



Amputation Prevention Center

Our Center is one of the few facilities nationwide that brings together the interdisciplinary expertise of vascular and podiatric surgeons with limb-salvage and wound-management specialists in a state-of-the-art setting.



Children's Services

We provide compassionate and specialized pediatric care. Each member of our pediatric care team shares a family-centered approach to providing the treatment and support needed for positive outcomes. We are equipped to serve the individual health care needs of children from newborn to age 18.



Emergency Services

With several designations, our emergency services continues to demonstrate our commitment to excellent care. As a certified cardiac receiving center for heart attack patients, our specialists collaborate to provide critical care within 90 minutes of the onset of chest pain. In addition, our facility is a certified Primary Stroke Center. We have a dedicated stroke-focused program staffed by qualified, specially trained medical professionals who use advanced technologies to act quickly and save lives. Our Emergency Department is also designated as an Emergency Department Approved for Pediatrics, with expedited and specialized care for pediatric patients.



Heart & Vascular Services

We offer a full range of cardiac services to quickly and accurately diagnose and treat patients suffering from critical heart and vascular conditions. An expert, multidisciplinary medical team is dedicated to acting quickly and saving patients' lives.



Maternity Services

Our Maternity Services Department delivers more babies than any other hospital in the San Fernando Valley. We offer a family-centered approach and are dedicated to providing comfort and support through the journey of pregnancy, birth and early parenthood.

Emergency Department Renovation

The closing of 2018 proudly marked the completion of our Emergency Department renovation. The renovation occurred in five construction phases, over the course of three years. Without interruption of care to our community, Valley Presbyterian Hospital increased capacity, upgraded infrastructure and improved patient comfort so the nearly 70,000 emergency patients and their families that rely on us each year have a chance for better outcomes.

The expansion resulted in 10 more treatment beds, enabling physicians to treat more patients with greater effectiveness. At an average rate of 4-5 patients per day, per bed, that's up to 50 additional patients per day and more than 18,000 over the course of a year.





Outpatient Services

We offer many outpatient services through our general and gastrointestinal laboratories, Radiology/Imaging Department and therapy programs, including occupational, physical, respiratory and nuclear medicine.



Surgery Services

We provide a broad range of surgical services representing a wide array of specialty areas. Our physicians and surgical services staff have the tools and advanced technology they need to perform a full range of surgical procedures and to deliver the highest quality of care.



Valley Hip & Knee Institute

We specialize in the latest joint replacement techniques and minimally invasive procedures, helping patients to regain their mobility and resume the activities they love. Together with a dedicated care team, our orthopedic specialists quickly get patients back on their feet.



Wound & Hyperbaric Center

Our expert, multidisciplinary wound care team is dedicated to helping chronic wounds heal where traditional methods have failed. Treatments include advanced diagnostic testing, debridement, advanced wound-dressing technology, negative pressure therapy and many other techniques and technologies.

Patient Story

Receiving the news that you have cancer is a difficult experience. When one of our patients was diagnosed with follicular lymphoma cancer, she was feeling overwhelmed, anxious, and afraid. She was left wondering how she would cope with the days ahead.

Our patient was overwhelmed due to her lack of knowledge of her disease. When faced with her third round of intense and delicate chemotherapy, she was pleased when her nurse, Imelda helped keep her informed and calm throughout the process.

"Imelda was extremely knowledgeable, and she shared information in a compassionate manner," said Roberta. "She even changed her schedule to see me through the third round of treatments."

Imelda has been working at VPH since 2005. Imelda is known for her ability to teach and involve families in the plan of care. She maintains a positive attitude and is a great mentor for new team members. Her passion for nursing and educating patients and their family members has been recognized on numerous occasions.

As a result of the compassionate care provided to Imelda, she felt so compelled to nominate Imelda for the Daisy Award, which she was awarded in September 2018. By definition, compassion is an inherent quality or trait that enables a nurse to discern the individual needs of each patient.

Rosario Conti, RN, BS and Tempa Figueroa, RN, BSN

On September 17, 2018 Nurses Rosario "Rosie" Conti and Tempa Figueroa were working on the Specialized Medical Unit. At approximately 2:30 PM Rosie heard a gagging sound coming from a patient's room. She ran to the room and saw the patient with a patient belongings bag over his head. Rosie called for assistance and Tempa responded.

Both jumped into action. The patient had wrapped a phone cord around his neck and had the plastic patient bag over his head. The Nurses struggled to remove the cord because it was knotted and tied around his neck, all the while the patient was pushing and slapping at the nurses. Simultaneously, they pulled the plastic bag apart so the patient could breathe, they then removed the cords from his neck and provided aid.

Because of the nurses quick response and fast actions they saved this patient's life. Nurse Conti and Figueroa deserve the Josie King Award. This patient is alive because of their actions.

April 2018's DAISY® award is presented to Talia Kogan, RN, BSN, nominated for treating a patient like a beloved family member. Under Talia's expert care, a patient's anxiety and pain was well managed. Out of deep respect for her nurse, this patient wrote a wonderful testimony about her experience with Valley Presbyterian Hospital:

"Since my surgery, I have been in so much pain. The night shift came and went, and Talia was advised of my situation. Throughout the day, my pain got worse and I even threw up on my bed and the floor. I called Talia several times for many reasons, and each time she came into my room with a smile. I felt so bad, but each time she made me feel special. Not once did I feel uncomfortable or embarrassed. She talked with me and did not rush off because someone else called her. She explained everything so clearly that I understood it. She helped me to realize that I had surgery yesterday, and that I was not going to be at 100%.

I told Talia that she reminded me of my sister-in-law and her response was, 'I hope it's in a good way.' I told her 'yes, I love her. She is caring and has the most wonderful aura about her.' Talia showed me just how much she cared about my well-being. I did not feel like another assignment, I felt like I was the assignment! She was GREAT!"

Addressing the patient in this manner, demonstrated true compassion. By definition, compassion is an inherent quality or trait that enables a nurse to discern a need, provide comfort and help a patient feel safe and valued, like she was cared for by a family member that she dearly loved. Talia was an exemplar of this type of genuine compassion.

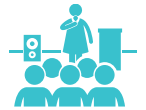

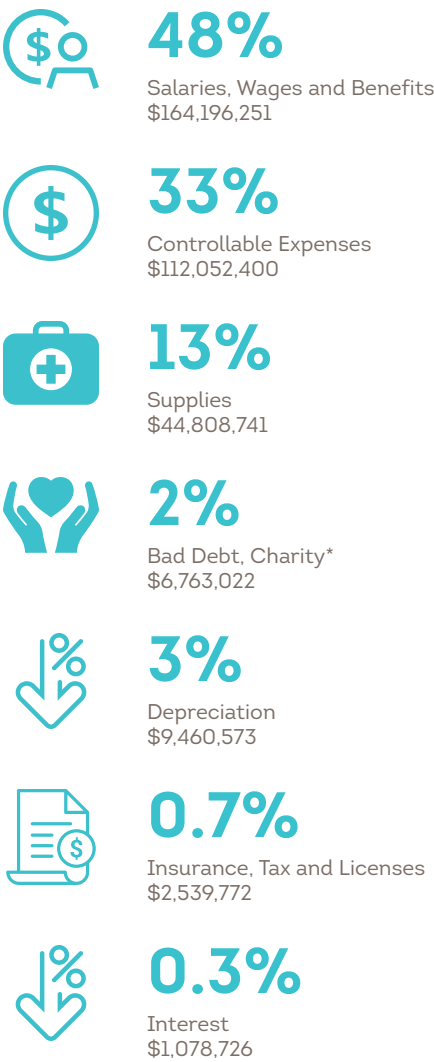

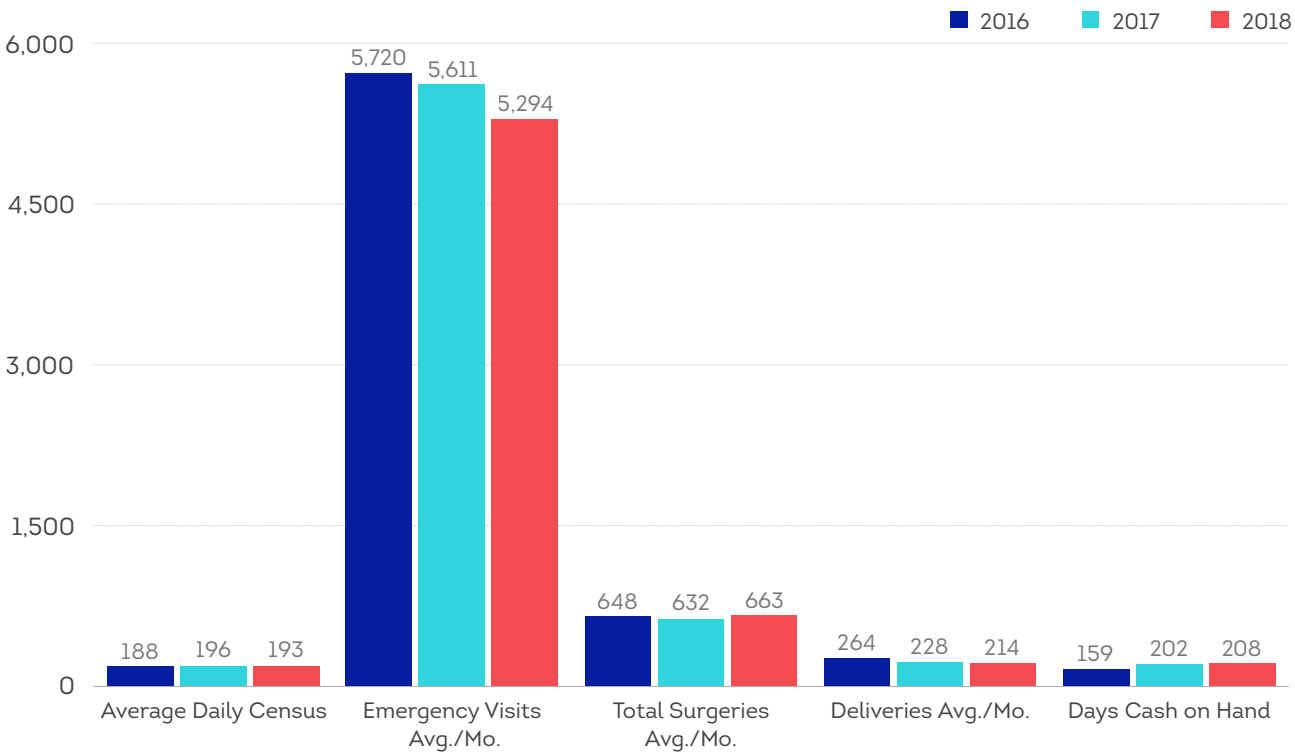

us to care for heart attack patients within the critical 90 minutes of an episode, 24/7; being a Certified Primary Stroke Center, providing immediate access to a neurologist and rapid treatment; our Pediatric Medical Center Designation, allowing our team of specialists to provide a higher level of care; and our Emergency Department Approved for Pediatrics (EDAP) designation, meaning that we have specialized pediatric teams who are ready at a moment's notice to assemble, triage, and fast-track children to get them care they urgently need.

We have started on our journey to be a Magnet recognized designation. As the highest honor in American nursing, we look forward to joining the 6 percent of the country's hospitals in achieving this recognition.

While our range of acute-care services and expertise has continued to expand, we remain a community-based hospital at heart. As one of the Valley's only independent, non-profit, and locally governed institutions, we provide an exceptional level of care that responds to the needs of our community.

Outcome Measure Definitions:

CLABSI - Central line-Associated Blood Stream Infection: A serious infection that occurs when germs enter the bloodstream through a central line. A central line is a special intravenous catheter (IV) that allows access to a major vein close to the heart and can stay in place for weeks or months. The value shown above is a Standardized Infection Ratio (SIR), which is the ratio of observed-to-expected infections during the measure period. SIRs below 1.00 indicate that the observed number of infections during the measure period was lower than would be expected under normal conditions, whereas values above 1.00 indicate that the observed number of infections was higher than expected. Limitations: In the calculation of the Standardized Infection Ratio (SIR), the CDC adjusts for differences between hospitals. However, patient risk factors are not taken into account. These patient-specific variables (e.g., poor skin integrity, immunosuppression) can increase the risk of developing a central line infection. Hence, the SIR for hospitals that care for more medically complex or immunosuppressed patients may not be adequately adjusted to account for those patient-specific risk factors.

Colon SSI - Colon Surgical Site Infection: An infection (usually bacteria) that occurs after a person has colorectal surgery that occurs at the body site where the surgery took place. While some involve only the skin, others are more serious and can involve tissues under the skin, organs, or implanted material. The value shown above is a Standardized Infection Ratio (SIR), which is the ratio of observed-to-expected infections during the measure period. SIRs below 1.00 indicate that the observed number of infections during the measure period was lower than would be expected under normal conditions, whereas values above 1.00 indicate that the observed number of infections was higher than expected. Limitations: Some, but not all patient-specific risk factors are included in the adjustment of the SIR for these types of infections. However, not all relevant risk factors are included (e.g., trauma, emergency procedures). Hence, the SIRs for hospitals performing more complex procedures or with larger volumes of trauma or emergency procedures may not be adequately adjusted to account for those patient-specific risk factors

NTSV - Nulliparous, Term, Singleton, Vertex Cesarean Birth Rate: The percentage of cesarean (surgical) births among first-time mothers who are at least 37 weeks pregnant with one baby in a head down position (not breech or transverse). Lower values indicate that fewer cesareans were performed in the hospital among primarily low risk, first-time mothers. Limitations: NTSV rates do not take into account certain obstetric conditions, such as placenta previa, that may make Cesarean delivery the safer route for both mother and infant.

Sepsis Mortality: Percent of patients, with a severe infection, who die in the hospital. Most sepsis cases (over 90%) start outside the hospital. Lower percentage of death indicates better survival. Limitations: Use of discharge/ administrative data is limiting since such data has lower specificity for diagnoses than clinical data. In addition, without risk adjustment for differences in patient-specific factors, comparing rates among hospitals is difficult.

VTE - Venous thromboembolism: The measure of patients who develop deep vein clots who had not received potentially preventive treatment. Limitations: Although not adjusted to account for patient-specific risk factors, this rate is helpful in distinguishing a hospital's adherence to the best practice of administration of appropriate VTE prophylaxis to all appropriate patients.
